

# **AWG Cookie Policy**

# PLEASE READ THIS COOKIE POLICY CAREFULLY BEFORE USING THE WEBSITE

This cookie policy (this **Policy**) sets out information about the cookies we use on the online platform for the Global Aircraft Trading System (**GATS**) currently hosted on the website, <u>http://e-gats.aero/</u> (the **Website**, and together with the GATS online platform, and all of the systems and architecture relating to it, the **GATS Platform**), and how those cookies work.

This Policy most recently updated on, and this version is effective as at, 21 May 2020.

This Policy applies to any person who is an individual accessing or using the GATS Platform in connection with that person's trade, business, craft or profession on behalf of a business which has its own legal identity separate from the legal identity of any individual or group or individuals.

#### 1. ABOUT THE GATS PLATFORM, WHO WE ARE AND HOW TO CONTACT US

- 1.1 The GATS Platform and the GATS helpdesk is operated by Fexco Unlimited Company (**Fexco**) on behalf of the Aviation Working Group (**AWG**, **we** and **us**).
- 1.2 Fexco is an unlimited company incorporated under the laws of Ireland with company number 83934 and has its registered office at Fexco Centre, Iveragh Road, Killorglin, Co. Kerry, Ireland.
- 1.3 AWG is a company limited by guarantee incorporated under the laws of Bermuda and has its registered office at Clarendon House, 2 Church Street, Hamilton HM11, Bermuda.
- 1.4 Persons accessing or using the GATS Platform may be referred to in these terms as **you** and **your**, as applicable.
- 1.5 We may amend this Policy from time to time. Every time you wish to use the GATS Platform, please check this Policy to ensure you understand the terms that apply at that time.
- 1.6 To contact us or the GATS helpdesk, please email <u>helpdesk@e-gats.aero</u> or call the helpdesk number listed on the GATS Platform.

## 2. BY USING THE GATS PLATFORM YOU ACCEPT THIS POLICY

- 2.1 By using the GATS Platform, you confirm that you accept the terms of this Policy.
- 2.2 If you do not agree to this Policy, you must not use the GATS Platform.
- 2.3 We recommend that you print a copy of this Policy for future reference.

#### 3. THERE ARE OTHER TERMS THAT MAY APPLY TO YOU

This policy forms part of and is incorporated into the <u>Site Terms of Use</u> for the GATS Platform. The <u>Site Terms of Use</u> as well as other terms, policies, notices, disclaimers and schedules incorporated into the <u>Site Terms of Use</u> also apply to your use of the GATS Platform.

#### 4. WHAT IS A COOKIE?

- 4.1 Cookies are text files containing small amounts of information which are downloaded to your device when you visit a website. Cookies are then sent back to the originating website on each subsequent visit, or to another website that recognises that cookie. Cookies are useful because they allow a website to recognise a user's device.
- 4.2 Cookies do lots of different jobs, like letting you navigate between pages efficiently, remembering your preferences and generally improve your website experience. They can also help to ensure that adverts you see online are more relevant to you and your interests.

- 4.3 Most websites you visit will use cookies in order to improve your user experience by enabling that website to 'remember' you, either for the duration of your visit (using a 'session cookie') or for repeat visits (using a 'persistent cookie').
- 4.4 Cookies may be set by the website you are visiting ('first party cookies') or they may be set by other websites who run content on the page you are viewing ('third party cookies').

# 5. HOW DO WE USE COOKIES ON THE WEBSITE?

Essential website cookies are required for technical reasons in order for the GATS Platform to operate and remain secure. We refer to these as 'essential' or 'strictly necessary' cookies. Such essential cookies also include functional cookies which are strictly necessary to allow you to use some of the features of the GATS Platform in order to receive and access your requested service. For instance, these cookies can be used to remember changes to any parts of the web pages, or any choices you have made, for the purposes of accessing your requested service, such as page navigation or your cookies and language preferences. Because these cookies are strictly necessary to deliver the GATS Platform and a number of its features, you cannot refuse them without impacting how the GATS Platform functions.

The specific types of cookies served through the GATS Platform and the purposes they perform are described in further detail in the below table.

Name	Description	When do cookies expire?	First or third party?
JSESSIONID	General purpose platform session cookie (to open java application session for user and to identify/store a user's session on the server). This ensures the user can navigate the site correctly.	Deleted when user leaves Website	1st
LFR_SESSION_STATE_XXXX	This cookie is used only for controlling timestamp of user session expiration.	Deleted when user leaves Website	1st
COMPANY_ID	This cookie stores portal site ID (this is an ID for the library application and is not specific to the user).	Deleted when user leaves Website	1st

## 6. MANAGING AND DISABLING COOKIES

- 6.1 You can block cookies by activating the setting on your browser that allows you to refuse the setting of all or some cookies. However, if you use your browser settings to block all cookies (including essential cookies) you may not be able to access all or parts of the GATS Platform.
